

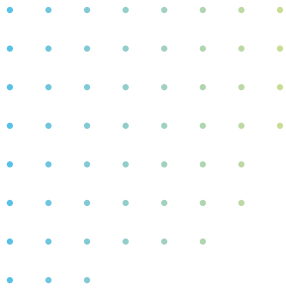

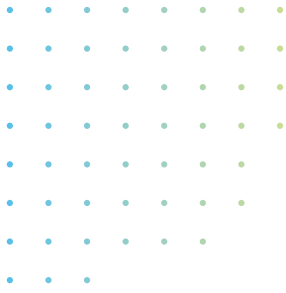
Next Landmark International AWARD 2021

Definition and Theme
of the Award

Definition and Theme of the Award

The Next Landmark International Award, now in its tenth year, is organized as a "Contest of ideas" with an open and anonymous procedure (pursuant to article 156 of Legislative Decree no. 50/2016) and the aim of rewarding two projects dedicated to sustainable functional mixing.

Designers can submit entries in one of the following categories:

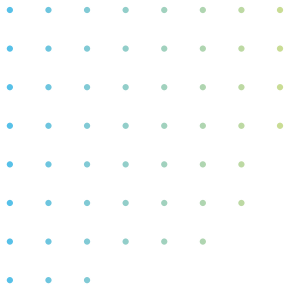
1. Landmark of the Year Award, by entering a completed project.
2. Research Award, by entering an unrealized project, either academic (e.g. thesis) or developed independently (e.g. research)

In both cases, the proposal must plan for an achievable future that revolves around inclusion and respect for people and nature. In other words, new ways of experiencing urban, public and private spaces as an economic, environmental opportunity that creates a feeling of collective belonging.

The following types of projects are acceptable under the functional mixing umbrella:

- Urban regeneration projects that support the transition from industry to services and the non-profit sector, conceived or implemented in structures that reflect the new ways of using space, both urbanistically and architecturally.
- Projects that respond to functional diversification needs, and therefore create new crossover links for the growth of contemporary cities. Residential, commercial, infrastructure, leisure and other forms of architecture that are integrated with the neighborhood, street system or even individual buildings, creating a proximity and therefore sustainable network serving the needs of citizens.
- Public or private projects designed or implemented as nature-based solutions (NBS), in which human activities are integrated with nature, which in turn is managed responsibly and sustainably. Projects that have a long-term low environmental impact as their design basis.

In all three cases, the projects presented must define strategies that make a significant contribution to reducing the vulnerability of local communities to social, economic and environmental changes.

Entry Assessment Criteria

The following entry submissions are required:

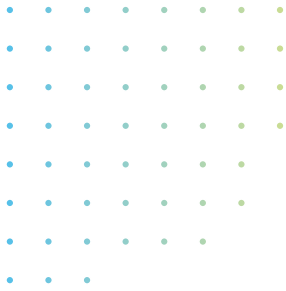
- Four photographs (for a completed project) or rendering (for an academic study or research) of the work in jpeg format 1280 x 1024 pixels 72 dpi
- Three project drawings containing plans, sections and elevations of your choice in jpeg format, 1280 x 1024 pixels 72 dpi
- Three images of your choice as deemed necessary to best describe the project (rendered images, photographs of models, sketches, schedules, etc.) in jpeg format 1280 x 1024 pixels 72 dpi image resolution.
- Project summary in English (maximum 1800 characters)

Documentation Required

For one of the three project types that come under the sustainable functional mixing umbrella, the award will be presented to the two works, one per category, considered to be most innovative.

The judging panel will take the following parameters into consideration:

- originality of the project or research
- long-term low environmental impact
- new ways of using space
- technical, aesthetic and conceptual innovation

Participation and Registration

The contest is open to any young designers and creative people from the fields of architecture and design who have graduated since 2010.

In order to ensure equal opportunities and for the purpose of subsequent publication, participants must comply with the following when submitting projects.

Entries may only be made by individuals and anonymously. To ensure anonymity, an alphanumeric code identifying the project will be assigned by the system when completing the registration form.

All materials must be uploaded by clicking on upload in the reserved area at the following address <http://www.floornature.com/nextlandmark/subscribe> accessible following registration. Once accredited, the requested materials can be uploaded anonymously. All files in the format requested will automatically be renamed by the system, with a code assigned in order to ensure anonymity in respect of the judging panel.

Once uploaded, no further changes may be made to the entry.

All entries must be uploaded by **May 30, 2021**

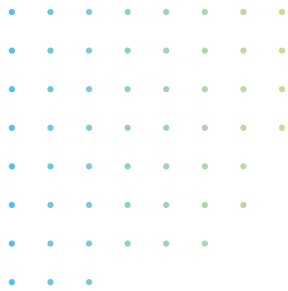
The entries made in accordance with the guidelines stated in this document will not be returned.

Judging Panel

The Judging Panel, whose decision will be final and unappealable, will be appointed by the organizations and institutions promoting the contest, and consist of five members:

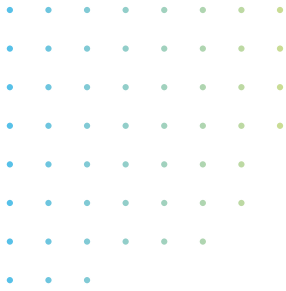

Processing of Personal Data

The personal data supplied by the candidates with the application form, pursuant to Legislative Decree 196/2003 and the EU Regulation 2016/679 on Data Protection, will be processed for the purposes of managing this contest.

Exclusions

The contest is not open to members of the Judging Panel, their spouses or relatives, employees of the organizing body, professional firms, Universities or associations to which the members of the Judging Panel belong. Entries that do not comply with the required terms of anonymity will be excluded from the contest.



Results and Publication

The judging panel will complete its work by **June 20, 2021**.

The results will be published on the <https://www.floornature.com/nextlandmark/winners> website by **June 30, 2021**.

The Judging Panel will publish a final report outlining the evaluation criteria and motivation in respect of the winning entry.

The organizers reserve the right to publish all entries submitted, including creating a catalog of entries intended to encourage professionals and in the general interests of the community.

Ownership of the Entries

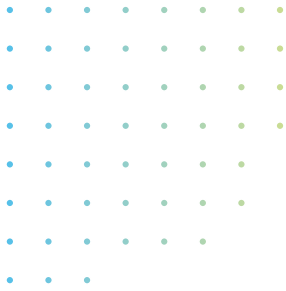
Ownership of the Entries

The organization reserves the right to suspend, extend, postpone or cancel this award at any time and for any reason.

The winners are chosen by the Judging Panel and their decision is final. The Judging Panel reserves the right, at its discretion, to exclude any project received that is not in line with the requirements indicated in the rules, even if previously uploaded to the website.

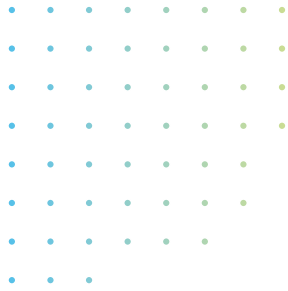
Participants nevertheless exempt the organizers from any liability to third parties deriving from use of the entries under the terms and for the purposes described in these rules.

The Judging Panel will evaluate the entrant's ability to interpret the theme, creativity and the technical content of the images submitted.

Exclusion Criteria

The following submissions will be excluded:

- Any entry which infringes common decency.
- Designs which are not in accordance with contest requirements.
- The Judging Panel may also exclude, at their discretion, those whose conduct is not consistent with fair competition.



Consent

By submitting an entry, participants accept, without reservation, the conditions outlined in the call for submissions and consent to be bound by the Judging Panel's assessments, both for interpretation of the call for submissions and evaluation of the competing designs.

The Promoter accepts no responsibility for any problem or circumstance that might impede the running of, or participation in, this award.

The authors of entries guarantee that they are exclusively their own work and ingenuity and meet the requirements of innovation and originality.

All matters not expressly provided for in the rules, will be governed by the general provisions of applicable community, national and regional legislation. If the organizers find any infringement of the rules by participants, they have the right to disqualify the entry at any time without liability.

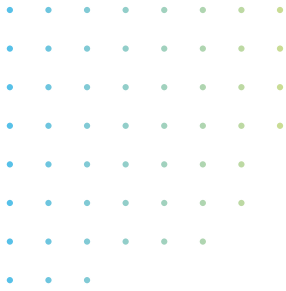

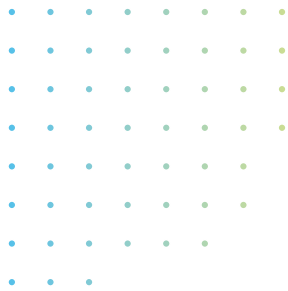
